Those associations that have a significant statistical difference ( $p < 0.01$ ) are shown in bold. Correlation between HR survival curves between Microarray based versus RNA-seq based analysis. Samples in bold show significant statistical significance ( $P<0.01$ ). One star suggest discordance in cohorts that don't reach statistical significance on their own; two stars suggests discordance where either the microarray or the RNA-seq cohort have reported statistical significance; and three stars denotes situations where both the microarray and RNA-seq analysis cohort reported the finding as significant.
